MOVED to approve Findings 1, 2, and 3, as recommended in the Memorandum from the Chief Compliance Officer and the Audit Division dated July 21, 2023.

The motion carried by a vote of 6-0 with Commissioners Broussard,

Cooksey, Dickerson, Lindenbaum, Trainor, and Weintraub voting affirmatively for the decision.
