11	We are responding to your advisory opinion re	equest on behalf of
12	PoliticalMeetings.com, LLC, ("PM.com") concerning the application of the Federal	
13	Election Campaign Act, 52 U.S.C. §§ 30101-45 (the "Act"), and Commission regulations	
14	to PM.com's proposal to allow its subscribers to make small, monthly contributions to	
15	candidates and national political party committees via the PM.com's web-based platform	
16	and to provide subscribers access to non-public information about political meetings and	
17	events with recipient candidates and national party committees.	
18	The Commission concludes that PM.com's pr	oposal is permissible under the Act
19	and Commission regulations and that the proposal wo	ould not constitute contributions
20	from PM.com — or you as the sole member of PM.co	om — to candidates or national
21	political party committees.	
22	Background	
23	The facts presented in this advisory opinion as	re based on your letter received on
24	February 1, 2024, and the politicalmeetings.com web	site.1
25	PM.com was founded in 2023 by you, its sole	member. The LLC is registered
26	with the Colorado Secretary of State as a sole proprie	torship and is treated as such for

- 1 federal income tax purposes.² PM.com asserts that it intends to convert from an LLC to a
- 2 limited liability partnership ("LLP") in the future.³
- 3 PM.com is a web platform designed to provide the public with information about
- 4 candidates and national party committees and meetings held by them.⁴ You state that
- 5 PM.com was established to fill a national void of information about political meetings
- 6 held by candidates and national party committees.
- 7 PM.com will gather and publish on its platform public information about
- 8 candidates and national party committees, which will be available to all visitors of the
- 9 website.⁵ To this end, using information from public sources such as the public websites
- of candidates, Secretaries of State, and the Commission, PM.com will gather lists of
- candidates and will provide a "Basic Profile" of each candidate, including the office they
- seek and their campaign committee's contact information. Additionally, PM.com's
- 13 "[i]n-house data teams" will locate meetings held by candidates and national party

Id. PM.com will also include candidates for local and state offices in the largest three counties of each state and will allow small contributions to certain non-profit organizations. Id. This advisory opinion applies only to PM.com's operation regarding federal candidates and national political party committees. Accordingly, all references to "candidates," "national party committees," "participant committees," or "recipient committees" in this opinion refer to federal candidates and national political party committees that have been recognized as such by the Commission. At the time of this advisory opinion, the available national parties on PM.com are the Democratic, Republican, Libertarian, and Green parties. - 1 committees on the local, state, and national levels in the top three largest counties of each
- 2 state.⁸
- 3 PM.com will offer its website visitors the ability to subscribe to its services for
- 4 additional benefits. Subscribing allows viewers to make contributions of \$1.00 per
- 5 month through PM.com to candidates who opt to participate. Subscribers can also
- 6 choose to add a \$0.50 monthly contribution to a participating national party committee. 10
- Additionally, subscribers will have access to "Enhanced Profile[s]" of candidates and
- 8 national party committees containing information about non-public meetings held by
- 9 participating candidates and national party committees. 11
- 10 PM.com will require subscribers to complete a Subscription Registration Form
- that will include disclaimers and require contributor information as required by the Act
- 12 and Commission regulations. 12 If, based on the information provided by the potential

This form will include disclaimers that candidates and other political committees are required to use best efforts to report information for contributions aggregating over \$200 in a calendar year from each contributor; that contributions made through PM.com will be aggregated by recipients with any other contributions made to them from each subscriber; and that contributor information will be made public once reported to the Commission by the recipients. *See* AOR008. This form will further state that contributions must comply with the federal limits and prohibitions. AOR004. Finally, each subscriber will have to certify that they are a legal contributor: Subscribers will have to provide the following information and attest that it is true and accurate:

^{1.} Legal name;

^{2.} Mailing address;

^{3.} Occupation and Employer;

^{4.} Subscriber is not a federal contractor;

^{5.} Subscriber is using their own personal funds and not funds given to them by another person for the purpose of making the contribution;

^{6.} Subscriber is using their own personal credit card and not a corporate or business card, or a card issued to another person;

- subscriber, the individual is ineligible to make contributions, "the platform will not allow
- 2 [the contributor] to proceed."¹³ For eligible subscribers, the form will enable them to
- 3 choose the party affiliation of the candidates they wish to contribute to, and the option to
- 4 add a monthly \$0.50 contribution to a national party committee. 14
- 5 PM.com will charge a base subscription rate of \$2.98 per month, which will
- 6 include a one-dollar contribution to a candidate and an administrative fee of \$1.98 paid to
- 7 PM.com to cover their operational costs. 15 Subscribers may add to their subscription
- 8 \$1.00 monthly contributions to as many participating candidates as they wish and a \$.50
- 9 monthly contribution for a national party committee. ¹⁶ PM.com will charge the
- subscriber an additional \$1.98 administrative fee for every three additional candidates
- 11 contributed to by the subscriber. 17
- In addition to the ability to contribute to participating candidates and national
- party committees, subscribers "[will be able to] search for meetings . . . listed by
- candidate's name, state, entity name or 'key word' within the same party affiliation" 18
- and will have access to further nonpublic information gathered by PM.com.

Operational costs include items such as "data research, payroll, accounting, legal office and other expenditures arising in the normal course of work on a day-to-day basis." AOR006.

Subscribers may also include donations to up to five non-profit organizations chosen by PM.com, which will be focused on supporting the homeless population of the United States. *See* AOR002. As noted in note 4 above, this advisory opinion does not address any donations to nonfederal candidates or to non-profit organizations or their effect on the total subscription costs and payment processing fees.

1 Candidates and national party committees may participate in PM.com's platform 2 without charge. To participate, they must agree to PM.com's "Permission Slip," which 3 will require them to provide PM.com with bank account or pay gateway information and 4 allow the pay gateway processing company, in this instance Stripe, to directly deposit contributions into their designated bank accounts. 19 Further, participating candidates and 5 6 national party committees will have to agree to provide PM.com with information about 7 their "meetings or events that are ordinarily not open to the public."²⁰ 8 When a candidate opts to participate, their Basic Profile, previously populated by 9 PM.com using only public information, will be "converted to an 'Enhanced Profile."²¹ 10 The Enhanced Profile will have three features in addition to the Basic Profile provided to 11 the general public.²² These features will include: 1) a link to a page that will allow 12 subscribers to contribute to a candidate or national party committee, 2) a link to a page 13 containing content in the PM.com's database, which will include, for example, information about non-public fundraisers and special events, ²³ and 3) a dashboard where 14 15 the participating candidates and committees may track donations and run reports.²⁴ 16 Participating candidates and committees "would be required to complete a form or email

PM.com "will make those meetings and invitations available exclusively to those [subscribers contributing] to the respective candidates [who] have the Enhanced Profile." AOR008.

1 PM[.com] with any information it would like published or information on meetings or

2 fundraisers" and may include a link to their campaign websites. ²⁵

3 PM.com will use Stripe, a pay gateway company, to process contributions and

4 administrative fees paid by the subscriber.²⁶ The current fee for processing contribution

transactions on PM.com is 2.9% plus \$.30 per transaction.²⁷ The subscriber generally

pays the transaction fees charged by the pay gateway in addition to their total

7 subscription of more than \$3.48.²⁸

8 Stripe will split the funds paid through PM.com and will directly deposit the

contributions to candidates and national party committees using the account information

they provided.²⁹ PM.com does "not accept [contributions] on behalf of [recipient

committees]. Should an error occur where funds were inadvertently deposited into [a]

12 [PM.com] bank account," the error would be corrected within two business days.³⁰

Stripe would deposit the remaining funds (total subscription amount minus the

contributions) into the PM.com's "Subscription Account." Once PM.com reconciles

the Subscription Account with Stripe, it will transfer the administrative fees to its own

"Operating Account."

PM.com will pay the transaction processing fees on subscriptions totaling less than \$3.48 monthly. This allows the subscriber to contribute to one candidate and one national party committee without having to pay the transaction processing fees. For subscriptions costing more than \$3.48 per month, the subscriber pays the transaction processing fees. *See* AOR005 (chart).

Question Presented

1

2 *Is PM.com's proposal to allow its subscribers to make small, monthly* 3 contributions to candidates and national political party committees and to provide them 4 with non-public information about political meetings and events with the recipient 5 candidates and committees permissible under the Act and Commission regulations? 6 Legal Analysis 7 Yes, PM.com's proposal would be permissible under the Act and Commission 8 regulations, and the proposed subscription service would not constitute a contribution 9 from PM.com or you, as PM.com's sole member, to candidates or national political party 10 committees. 11 The Act and Commission regulations provide that a "contribution" includes any 12 "gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for Federal office. "32 "[A]nything of 13 14 value" includes in-kind contributions such as the provision of good or services without 15 charge or at a charge that is less than the usual and normal charge.³³ Commission 16 regulations define "usual and normal charge" for goods or services as "the price of those goods in the market from which they ordinarily would have been purchased at the time of 17 18 the contribution" or the "commercially reasonable rate prevailing at the time the services

were rendered," respectively.³⁴

- 1 In several previous advisory opinions, the Commission concluded that companies
- 2 that process contributions as a service to contributors without receiving compensation
- 3 from the recipient political committees were not making contributions³⁵ because the
- 4 companies were not providing services to the political committees.³⁶ The Commission
- 5 has also approved proposals in which companies that process contributions as a service to
- 6 contributors provide contributors with tools to gather information about and to evaluate
- 7 potential recipient candidates.³⁷ The Commission has reasoned that providing such

- 1 information is a "corollary of creating a web platform through which users [can] identify
- 2 political committees and transmit contributions."³⁸
- 3 PM.com's proposed service to its subscribers closely resembles the services
- 4 approved by the Commission in Advisory Opinion 2015-15 (WeSupportThat.com),
- 5 Advisory Opinion 2014-07 (Crowdpac), Advisory Opinion 2012-22 (skimmerhat), and
- 6 Advisory Opinion 2011-19 (GivingSphere). Here, as in those advisory opinions,
- 7 PM.com proposes to develop a for-profit, web-based platform through which it provides
- 8 information to subscribers so that they can identify and make contributions to political
- 9 committees. Contributions will be transmitted to candidates and national party
- 10 committees at the choice of the subscribers and not pursuant to any agreement between
- PM.com and the recipient political committees.³⁹ Because PM.com will provide these
- services to its subscribers rather than to the recipient political committees —
- 13 PM.com's proposal is analogous to widely available services that contributors may use to
- send contributions, such as United Parcel Service or electronic bill-pay services provided
- by banks. 40 And because the administrative fees that PM.com will collect are "for the

- benefit of the contributors, not of the recipient political committees," such fees "d[o] not
- 2 "relieve the recipient political committees of a financial burden they would otherwise
- 3 have had to pay for themselves." Accordingly, as in the prior advisory opinions,
- 4 neither PM.com's services nor its fees are contributions to the recipient political
- 5 committees. For the same reasons, PM.com's proposal to utilize Stripe's platform to
- 6 process and forward subscribers' contributions to candidates and national party
- 7 committees would not result in contributions from PM.com to the recipient committees.
- 8 PM.com's proposal to provide subscribers with Enhanced Views of the pages for
- 9 the candidates and the national party committees to which they choose to contribute
- through the platform is also similar to those approved by the Commission in previous
- advisory opinions. ⁴² The Enhanced Views would be an added service to PM.com's
- subscribers and would not constitute a contribution by PM.com to the recipient
- 13 committees because it would not relieve the candidates and national party committees
- 14 from a financial burden they would otherwise have to pay themselves. Accordingly,

1	PM.com's provision of this information to its subscribers is also permissible under the	
2	Act and Commission regulations.	
3	In sum, the Commission concludes that PM.com's proposal is permissible under	
4	the Act and Commission regulations and that the proposal would not constitute	
5	contributions from PM.com — or you as the sole member of PM.com — to candidates of	
6	national political party committees.	
7	This response constitutes an advisory opinion concerning the application of the	
8	Act and Commission regulations to the specific transaction or activity set forth in your	
9	request. See 52 U.S.C. § 30108. The Commission emphasizes that, if there is a change	
10	in any of the facts or assumptions presented, and such facts or assumptions are material to	
11	a conclusion presented in this advisory opinion, then the requestor may not rely on that	
12	conclusion as support for its proposed activity. Any person involved in any specific	
13	transaction or activity which is indistinguishable in all its material aspects from the	
14	transaction or activity with respect to which this advisory opinion is rendered may rely or	
15	this advisory opinion. See id. § 30108(c)(1)(B). Please note that the analysis or	
16	conclusions in this advisory opinion may be affected by subsequent developments in the	
17	law including, but not limited to, statutes, regulations, advisory opinions, and case law.
