**JOINT STIPULATION OF DISMISSAL WITH PREJUDICE**

On May 31, 2018, Defendant Federal Election Commission made a final production of records responsive to Plaintiff Rudy Takala’s Freedom of Information Act (“FOIA”) request, number 2017-003. Subsequent to that production, counsel for Plaintiff and Defendant were able to resolve all remaining issues regarding the adequacy of Defendant’s search and response.
