MOTION FOR LEAVE TO FILE BRIEF OF AMICI CURIAE

The States of Ohio, Alaska, Arkansas, Indiana, Iowa, Kansas, Kentucky, Louisiana, Mississippi, Nebraska, South Carolina, Texas, and Utah move the Court for leave to file this amicus brief at the *en banc* merits stage. This motion is perhaps unnecessary, as States need not seek leave to file *amici curiae* briefs during either initial consideration of a case on the merits, F.R.A.P. 29(a)(2), or during consideration of whether to grant rehearing, F.R.A.P. 29(b)(2). But because the rules do not expressly permit *amicus* briefs at the *en banc* merits stage, the States respectfully move for leave.

States have strong interests not only in how our citizens select our federal representatives, but also in protecting the associations of those citizens to promote their candidates through political parties. Additionally, the States' own experience with campaign finance further undermines any anticorruption rationale. Thus, the *amici* States have a strong interest in, and relevant knowledge about, the question presented.

For these reasons, this Court should grant the States' motion for leave.
