REPORT OF THE AUDIT DIVISION ON THE

NATIONAL COMMUNITY PHARMACISTS ASSOCIATION POLITICAL ACTION COMMITTEE EXECUTIVE SUMMARY

The National Community Pharmacists Association Political Action Committee registered with the Federal Election Commission on July 23, 1975 as the National Association of Pharmacists Political Action Committee. The Committee maintains its headquarters in Alexandria, Virginia.

The audit was conducted pursuant to 2 U.S.C. §438(b) of Title 2 of the United States Code that states, in part, that the Commission may conduct audits and field investigations of any political committee required to file a report under Section 434 of this title.

The audit was for the period January 1, 1999 through December 31, 2000. The Audit staff found that the Committee met the threshold requirements for substantial compliance with the Federal Election Campaign Act, as amended. The Commission approved the Final Audit Report on July 11, 2002.

I. BACKGROUND

A. AUDIT AUTHORITY

This report is based on an audit of the National Community Pharmacists Association, Political Action Committee (Pharmacists), undertaken by the Audit Division of the Federal Election Commission (the Commission) in accordance with the provisions of the Federal Election Campaign Act of 1971, as amended (the Act). The audit was conducted pursuant to Section 438(b) of Title 2 of the United States Code that states, in part, that the Commission may conduct audits and field investigations of any political committee required to file a report under Section 434 of this title. Prior to conducting any audit under this subsection, the Commission shall perform an internal review of reports filed by selected committees to determine if the reports filed by a particular committee meet the threshold requirements for substantial compliance with the Act.

B. AUDIT COVERAGE

The audit covered the period from January 1, 1999 through December 31, 2000. The Pharmacists reported a beginning cash balance of \$18,612; total receipts for the audit period of \$137,187; total disbursements for the audit period of \$139,725; and ending cash balance of \$16,073.

C. CAMPAIGN ORGANIZATION

The Pharmacists registered with the Commission on July 23, 1975 as the National Association of Pharmacists Political Action Committee and changed its name to the National Community Pharmacists Association Political Action Committee on April

Page 3 of 9 Approved July 11, 2002 14, 1997. The Pharmacists maintains its headquarters in Alexandria Virginia and its treasurer is Mr. John Rector who also served as treasurer during the period covered by the audit.

To manage its financial activity, the Pharmacists maintained one bank account. The committee receipts were comprised of approximately 1,555 contributions from individuals, totaling \$133,449. The accounting and record keeping functions were performed by the committee using commercially available management software. The Pharmacists did not file its disclosure reports electronically during the period covered by the audit. Paid staff who had not attended any FEC seminars performed the record keeping and reporting functions.

D. AUDIT SCOPE AND PROCEDURES

Following Commission-approved procedures, the Audit staff evaluated various risk factors to determine the scope of this audit. The audit included testing of the following general categories:

- 1. The receipt of contributions or loans in excess of the statutory limitations:
- 2. The receipt of contributions from prohibited sources, such as those from corporations or labor organizations;
- 3. Proper disclosure of receipts from individuals, political committees and other entities, to include the itemization of contributions or other receipts when required, as well as, the completeness and accuracy of the information disclosed;
- 4. Proper disclosure of disbursements, including the itemization of disbursements when required, as well as, the completeness and accuracy of the information disclosed;
- 5. Proper disclosure of debts and obligations;
- 6. The accuracy of total reported receipts, disbursements and cash balances as compared to bank records.
- 7. Adequate record-keeping for transactions; and,
- 8. Other audit procedures that were deemed necessary in the situation.

As part of the Commission's standard audit procedures, an inventory of Pharmacists records was conducted prior to the audit to determine if the records were materially complete and in an auditable state. Based on our review of the records

presented, it was concluded that they were materially complete and the audits commenced immediately.

II. AUDIT FINDING AND RECOMMENDATION

Based on our examination of the reports and statements filed, and the records presented by the Pharmacists, no material non-compliance was detected.
