

CERTIFICATION


I, Laura E. Sinram, Acting Secretary and Clerk of the Federal Election Commission, do hereby certify that on August 29, 2019, the Commission failed by a vote of 2-2 to make a finding that the Tennessee Democratic Party violated the joint fundraising regulations at 11 C.F.R. § 102.17(c) when it received \$3,021,100 in net proceeds from the Hillary Victory Fund joint fundraising committee (HVF), and then on the same day, transferred \$2,161,100 to the Democratic National Committee and \$850,000 to three designated state party committees, as recommended in the Memorandum from Chair Ellen L. Weintraub dated August 29, 2019.

Commissioners Walther and Weintraub voted affirmatively for the motion.
Commissioners Hunter and Petersen dissented.


