MOTION FOR INJUNCTION PENDING APPEAL

Free Speech respectfully moves this Court for an injunction pending appeal of this Court's October 3, 2012 ruling denying Plaintiff's motion for preliminary injunctive relief (Docket Nos. 41–42). *See* Fed. R. App. P. 8(a)(1)(C). Because of the limited time before the November 6, 2012 elections and because the standards for an injunction on appeal are the same as those for preliminary injunctions, Free Speech incorporates its filed Memorandum in Support of Preliminary Injunctive Relief (Docket No. 20) to support this motion. Plaintiff also intends to file a motion for injunctive relief with the Tenth Circuit as soon as feasible to effectuate relief in this case.
