FEC RELEASES YEAR-END 1978 REPORT ON 1977-78 FINANCIAL ACTIVITY OF NON-PARTY AND PARTY POLITICAL COMMITTEES

WASHINGTON - The latest summary figures concerning the financial activity of non-party ("PAC") political committees and party committees for the 1977-78 election cycle were released today by the Federal Election Commission.

The figures show that "PAC's" contributed \$35.1 million to federal candidates. The 2 major parties directly contributed a total of \$6.4 million to federal candidates, and sent an additional \$4.4 million on their behalf.

The computerized information is based on 1977-78 reports filed with the FEC by all non-party and party-related political committees at the National, State and local level. Information is complete for the period beginning January 1, 1977, through December 31, 1978, and includes financial information for 1978 primary and general elections as well as for 1977-78 special elections.

NON-PARTY POLITICAL COMMITTEES - "PAC's":

FEC figures for "PAC's" are summarized in categories according to the sponsoring organization, i.e., corporate, labor, non-connected, trade/membership/health, cooperative and corporation without stock. The total number of non-party committees included in the summary is 1,938. This is the number of "PAC's" which were involved at some point during the 1977-78 election cycle. It is NOT the number of "PAC's" currently registered, since many have ceased operation and new registrations are received daily. Based on information filed with the FEC, the following observations can be made:

- 75% of the non-party political committees (1,459 of 1,938 committees) contributed \$35.1 million to federal candidates
- House candidates received \$24.92 million
Senate candidates received \$10.13 million
Presidential candidates received \$.05 million
- Incumbents received \$19.98 million (56.9%)
Challengers received \$7.75 million (22.1%)
Open-Seat candidates (no incumbent running) received \$7.37 million (21.0%)
- Democrats received \$19.73 million (56.2%)
Republicans received \$15.35 million (43.7%)
Minor party and independent candidates received \$.02 million (.04%)

Attached are tables summarizing non-party committee activity and a list of the top 10 political committees in 4 categories (gross receipts minus transfers from affiliated committees, gross disbursements minus transfers to affiliated committees, total contributions to candidates by dollar amount, and latest cash-on-hand). Also included is a list of the top 10 corporate committees, labor committees, non-connected organizations, trade/membership/health, cooperatives, and corporations without stock committees within each of the 4 categories.

PARTY-RELATED COMMITTEES:

Together, the major parties contributed \$6.4 million to federal candidates and spent \$4.4 million on their behalf in general elections.

326 Democratic party-related committees contributed \$1.8 million to federal candidates and made expenditures totalling \$.3 million on their behalf in the 1978 general election. 359 Republican party-related committees contributed \$4.5 million to candidates for federal office and expended an additional \$4.1 million in general election efforts. (Note: the expenditure figures may include amounts spent in 1977-78 special election efforts as well as 1978 general elections. These spending limits are allowed for general elections (including special-general elections) only. Expenditure limitations vary for Senatorial races, depending upon the voting age population of the state. Expenditures for House races are limited to \$12,290 for states with more than one district.)

The following charts provide summary information on the financial activity of the two major parties at the National, State and local levels, and indicate the distribution of funds between House and Senate races, as well as among incumbents, challengers, and open-seat candidates.

Figures in this latest FEC release supercede figures contained in five earlier interim releases of March, April, September and November of 1978 and of January 1979.

SPECIAL NOTE: As in previous releases, the FEC notes that the figures contained in this latest release are NOT FINAL, but are subject to change after all 1977-78 related reports and amendments have been received and computerized.
