## FEC RELEASES SIX-YEAR SUMMARY ON 1986 SENATE INCUMBENTS

WASHINGTON -- In advance of year-end campaign finance filings by candidates, which will cover the second six months of 1985, the Federal Election Commission has compiled a summary of activity by Senate incumbents who are involved in 1986 re-election campaigns. This summary will provide an overview of money raised and spent in the intervening years since the senators' last election in 1980.

Individual senators are listed with total receipts and disbursements for each two-year election cycle. Contributions from individuals and from PAC's also are listed for each cycle. The cash-on-hand and debts owed by each candidate's campaign are provided as of December 31, 1980, and June 30, 1985.\* This allows the reader to understand the financial status of each campaign following the 1980 election, and provides information on the financial status most recently reported to the FEC.

The computerized information may be supplemented by researching the actual reports, which are on microfilm at the FEC. Some of the financial activity reported during the six-year period may relate to a prior election and should not automatically be presumed to be part of a candidate's 1986 election effort.

\*NOTE: PAC contributions are included as reported on PAC financial reports. Those PAC contributions reported in late June 1985 may not have been included in total receipts reported by candidates.
