FEC FINAL REPORT ON 1986 PAC ACTIVITY

WASHINGTON — Final Federal Election Commission statistics on 1985-86 PAC finances were released today. The study included 4,596 PAC's. Of this number, only 3,187, or 69%, actually contributed to federal candidates. By the end of 1986, there were 4,157 in existence. The following are highlights of the FEC Report:

*PAC contributions to '86 Congressional candidates grew by 26% over 1984 levels. Contributions to candidates seeking election in 1985-86 rose 26% over their 1983-84 efforts. This is the same rate of increase as occurred between 1982 and 1984.

*Incumbents continue to receive the bulk of PAC contributions - almost 68%.

*Several interesting shifts in PAC contributions occurred during the '86 election cycle.

- A larger share of PAC money was given to Senate races than in past elections - approximately 10% more.
- Republican challengers for House seats received far less money than in past cycles.
- Appreciable increases can be seen for all House Democrats except incumbents.

*Independent expenditures made on behalf of or against 1986 Congressional campaigns totalled almost \$9.2 million.

1. The number of committees included in the top chart are the number of committees reviewed by the FEC for this study. In the bottom chart, the number of committees includes only those which actually made contributions to federal candidates.
2. Receipts and disbursements have not been adjusted for monies transferred between affiliated committees. For this reason, they are somewhat inflated.
3. Cash-on-hand is as of December 31, 1986, unless committee ceased reporting earlier in the election cycle or has not yet filed all reports.
4. In the bottom chart, there are two figures given for each category. The first represents the total amount contributed to all federal candidates, regardless of whether or not they sought election in 1985-86. The figure in parentheses is the amount contributed to candidates involved in elections in 1985-86.
5. Open seat races are those in which the incumbent never sought re-election.

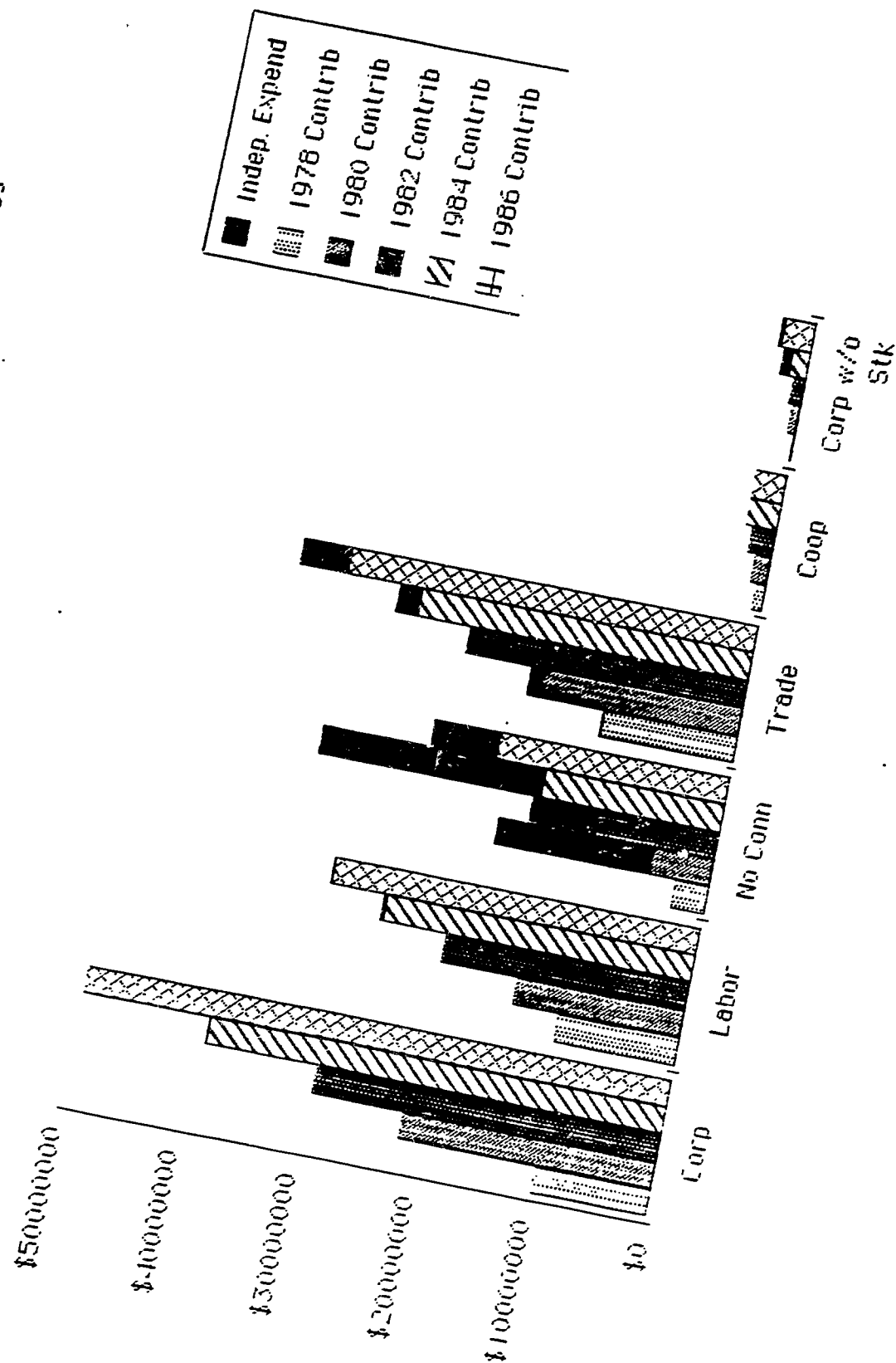

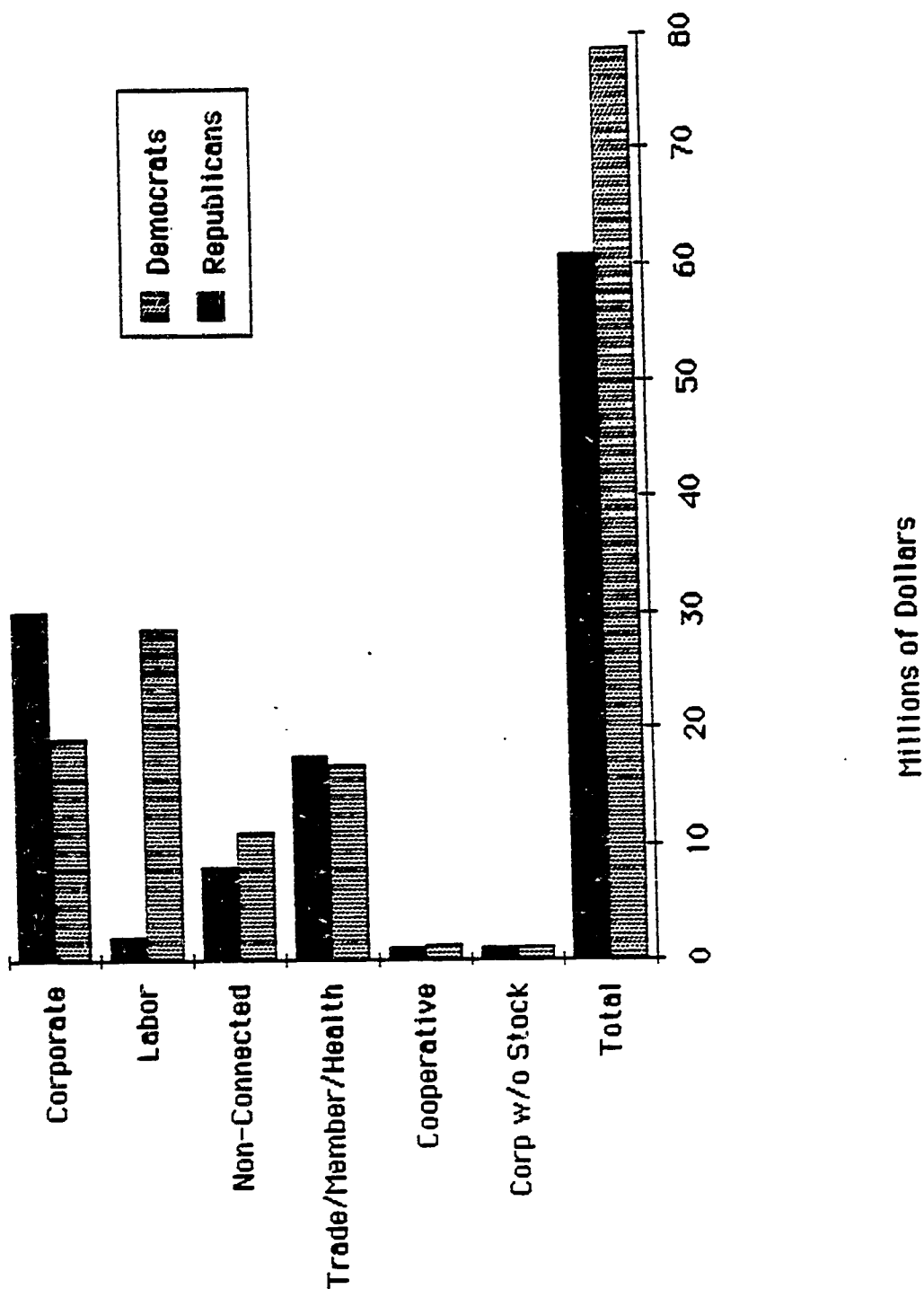
Committees: Support of Federal Candidates
