## FEC RELEASES SUMMARY OF 1989-90 POLITICAL PARTY FINANCES

WASHINGTON -- Final reports for the 1989-90 election cycle confirm that both major political parties are in debt. The Republicans ended the cycle with \$2.2 million cash on hand and a debt of \$8.3 million, while the Democrats have \$3.4 million cash on hand and owe \$5.6 million.

The Republican Party raised \$207.2 million and spent \$214.2 million, contributing \$2.9 million to federal candidates and spending \$10.7 million on behalf of special election and general election nominees. The Democratic Party raised \$86.7 million, spent \$92.1 million, contributed \$1.5 million to federal candidates and spent \$8.6 million on their behalf.

The following provides historical data on political party activity over seven election cycles.

Tables attached to this release offer summary data for political party committees at the national, state and local levels, showing total amounts raised and spent, and monies contributed to or spent on behalf of federal candidates. Pie charts and bar graphs provide additional illustration.

Another table highlights the financial activity of party committees in senate campaigns, listing contributions and coordinated expenditures by the national committees, the amounts transferred to each state by the national committee, and the amounts received by the state's senate candidate from other party committees. For the Republican Party, a compilation of proceeds to each state's senatorial candidate from the Inner Circle joint fundraising committee is also included. For the Democratic Party, coordinated expenditures made by the state party committees are listed for each state. (This information is not included on the Republican Party table, since the national level committee is authorized to spend the state party committees' coordinated expenditure amounts.)

An interesting aspect of political party activity during the 1989-90 election cycle was the increased amount of money given by party committees at the state and local level to candidates in other states. Included is a table, arranged by state, which portrays the amounts given by political party committees in each state to "other state" candidates and to "home" state candidates.

One final table lists by state the total amounts transferred by each of the national political party committees to state and local political party committees.

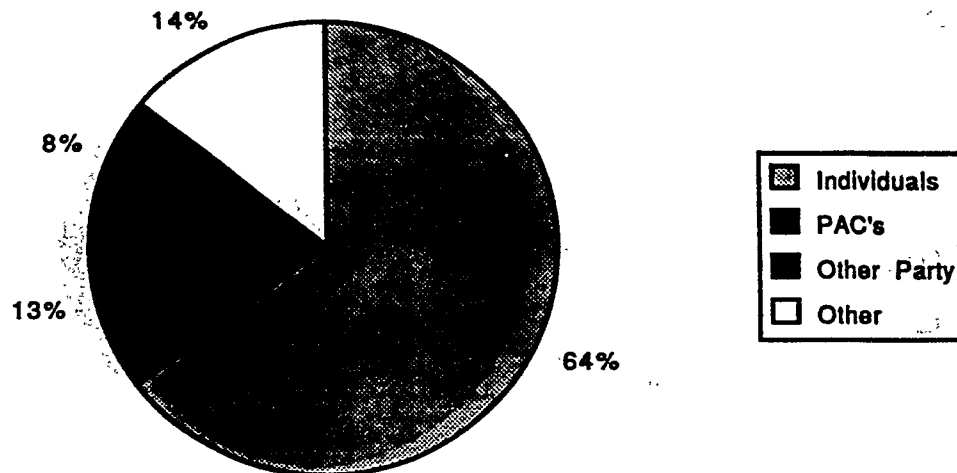

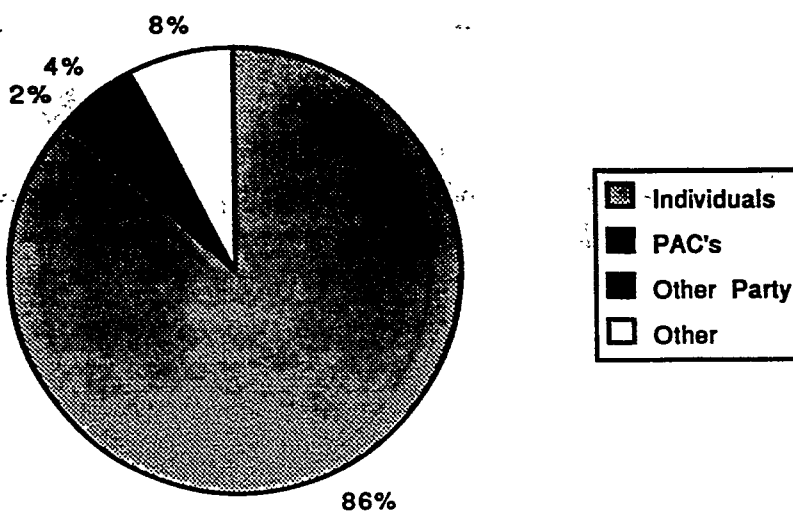

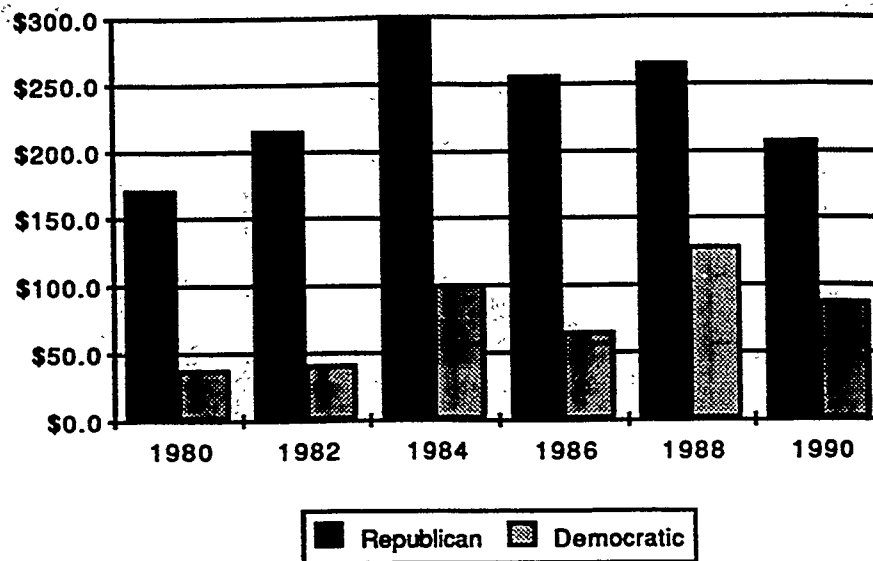

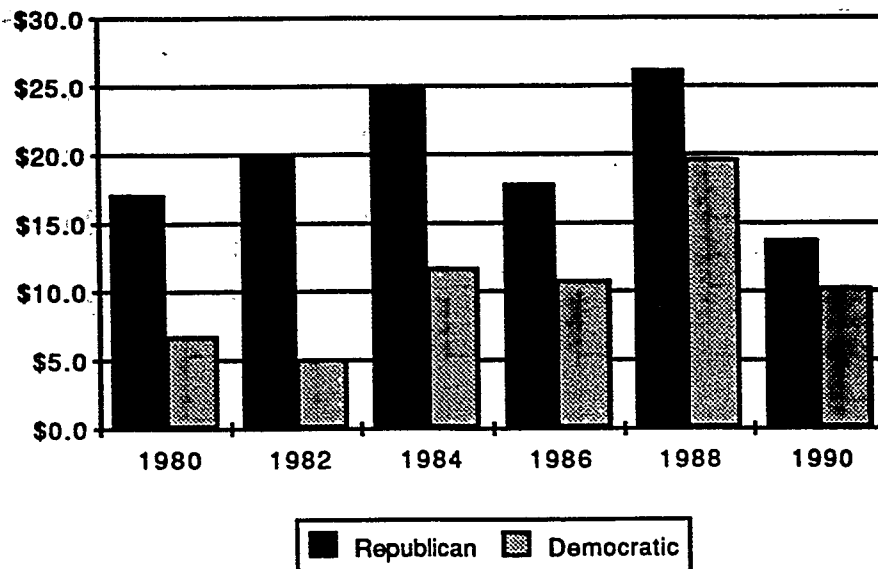
