1992 SENATE CAMPAIGNS SPEND OVER \$10 MILLION, MID-YEAR REPORTS SHOW

WASHINGTON -- Senate campaigns have spent more than \$10 million in the first six months of 1991, according to a report released today by the Federal Election Commission.

The FEC report is based on a compilation of reports from 55 campaigns which have registered thus far for 1992 Senate elections, and also provides information filed by two campaigns registered for the November 1991 special election to be held in Pennsylvania.

Mid-year filings by campaigns, covering January 1 - June 30, 1991, indicate that they raised \$33.3 million: \$20 million from individual contributors and \$9.4 million from PAC's or other committees. Campaigns began the second half of the year with just over \$44 million cash-on-hand and \$1.2 million in debts. (Financial activity for the Pennsylvania special election is not included in these figures.)

For comparison purposes, in the first six months of 1989, 45 candidates for 1990 Senate seats raised \$29.3 million and spent \$9.6 million, while 40 candidates for 1988 Senate races raised almost \$25 million and spent \$5.4 million from January through June 1987.

The listing which follows provides information on 35 Democrats and 22 Republicans, including Pennsylvania special election candidates. Financial activity for 1987-1990 is detailed for incumbents seeking re-election. Some of this activity may relate to a prior election and should not automatically be presumed to be part of the candidates' 1992 election efforts. For challengers and open-seat candidates, information is included from the inception of their campaigns.

The next reports for Senate campaigns (with the exception of those involved in the Pennsylvania special election) are due January 31, 1992, and will cover the last six months of 1991. The FEC will publish another statistical report after those reports are processed.
