## MEDIA FACT SHEET: 1996 PRESIDENTIAL MATCHING FUND REQUESTS

- \* The following is a compilation of information on submissions (requests) for matching funds made by presidential candidates certified eligible to receive federal matching funds.
- \* <u>Do not make the mistake of adding submission amounts together...some</u> requests are resubmissions. <u>Do not compare</u> what has been requested with what has been certified...because of resubmissions and adjustments made by the campaigns and by the FEC.
- \* Campaigns may submit requests once per month.
- \* Today was the date for the AUGUST submission. The FEC will review all submissions and, in late December, will certify to the U.S. Treasury the amount to be paid to each campaign. Treasury will pay those amounts early in January.
