Chair Ellen L. Weintraub called the Federal Election Commission to order in an open meeting at 10:24 A.M. on Thursday, June 13, 2013 with a quorum present.

She stated that Items III (Draft Interpretive Rule on Reporting Ultimate Payees of Political Committee Disbursements) and V (OGC Enforcement Manual) will be held over to the next meeting. She also explained that the Commission will take a short recess before consideration of Item IV (Proposed Final Audit Report on the California Republican Party/V8) to determine whether this matter can be resolved at today's meeting.

Chair Weintraub recognized Vice Chairman McGahn who

The motion carried by a vote of 5-0 with Commissioners Hunter, McGahn, Petersen, Walther, and Weintraub voting affirmatively for the decision.

Chair Weintraub recognized Vice Chairman McGahn who

**MOVED to suspend the rules on the timely submission
of agenda documents in order that the Commission may
consider Agenda Document Nos. 13-21 and 13-21-A.**

**Vice Chairman McGahn clarified, for the public, that these documents
(one from the General Counsel's Office and one from him and
Commissioners Hunter and Petersen) are not entirely consistent because
the General Counsel's document was edited after he and Commissioners
Hunter and Petersen had begun editing their document.**

**The motion carried by a vote of 4-0 with Commissioners Hunter,
McGahn, Petersen, and Weintraub voting affirmatively for the decision.**

**Chair Weintraub noted that Commissioner Walther had left the
meeting, as he is recused from the next Item on the agenda and will not
participate in its discussion.**

**Chair Weintraub recognized Ms. Esther Heiden of the General
Counsel's Office who presented the draft advisory opinion concerning the
application of the Federal Election Campaign Act of 1971, as amended, and**

Commission regulations to the request from Ms. Erin Bilbray-Kohn. Ms. Bilbray-Kohn is the former Executive Director and a former member of the Board of Directors of Emerge Nevada, a non-profit corporation holding tax-exempt status as a 527 organization. In its efforts to help elect candidates to state and local office, Emerge Nevada raises and spends non-federal funds and trains candidates in a number of subjects, including campaign fundraising. Ms. Bilbray-Kohn is considering running for the U.S. House of Representatives in 2014 and asks whether she may serve as a paid consultant, specifically providing training to candidates, to Emerge Nevada after she becomes a candidate.

Chair Weintraub recognized Vice Chairman McGahn who

MOVED to approve Agenda Document No. 13-20 and authorize the Office of the General Counsel to make any technical and conforming amendments.

The motion carried by a vote of 4-0 with Commissioners Hunter, McGahn, Petersen, and Weintraub voting affirmatively for the decision. Commissioner Walther was recused from this matter and did not vote.

The meeting recessed at 10:33 A.M. and reconvened at 11:26 A.M. with a quorum present.


