**I. CORRECTION AND APPROVAL OF MINUTES**

**Minutes for April 11, 2013  
Agenda Document No. 13-13**

**Chair Weintraub recognized Vice Chairman McGahn who**

**MOVED to approve Agenda Document No. 13-13, minutes for the open meeting of Thursday, April 11, 2013.**

**The motion carried by a vote of 5-0 with Commissioners Hunter, McGahn, Petersen, Walther, and Weintraub voting affirmatively for the decision.**

**Chair Weintraub stated that the agenda is being re-ordered to consider Item III (Draft Advisory Opinion 2013-02) before Item II (Draft Advisory Opinion 2012-38).**

**Chair Weintraub recognized Vice Chairman McGahn who**

**MOVED to waive the rules on the timely submission of documents so that the Commission may consider the late submission of Agenda Document Nos. 13-07-A, 13-15, and 13-14.**

**III. DRAFT ADVISORY OPINION 2013-02**

**Agenda Document No. 13-15 (Drafts A and B)  
(Submitted Late)**

**Chair Weintraub recognized Mr. Craig Engle, the requestor's counsel, who was available to answer Commissioners' questions.**

**Chair Weintraub recognized Ms. Jessica Selinkoff of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to the request received from Mr. Dan Winslow who is a candidate for the U.S. Senate in the Massachusetts April 30<sup>th</sup> special primary election. He asks whether his principal campaign committee may apply the spouse contribution rule at 11 C.F.R. 110.1(i) to contributions it receives from lawfully married same-sex couples. She summarized the conclusions reached in both drafts.**

**Mr. Engle participated in the discussion that followed.**

**Chair Weintraub recognized Commissioner Walther who**

**MOVED to approve Draft A subject to these amendments:**

- 1. In Footnote 2 on page 2, amend the second sentence to read:**

**A contribution from a joint account is attributed in accordance with 11 C.F.R. 110.1(k), regardless of the marital status of the contributors, since the political committee receiving the contribution may not know whether or not contributors are married.**

- 2. Replace Footnote 3 on page 4 with Footnote 3 on page 3 of Draft B, except delete the cite beginning “see also Perry v. Brown...”.**

**General Counsel Anthony Herman participated in the discussion that continued.**

**The motion carried by a vote of 5-0 with Commissioners Hunter, McGahn, Petersen, Walther, and Weintraub voting affirmatively for the decision.**

## **II. DRAFT ADVISORY OPINION 2012-38**

**Agenda Document No. 13-07 (Drafts A and B)  
(Held over from the meeting of February 14, 2013)**

**Agenda Document No. 13-07-A (Draft C)  
(Submitted Late)**

**Chair Weintraub recognized Ms. Cheryl Hemsley of the General Counsel’s Office who presented the draft advisory opinion concerning the**

**application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to the request received from the Socialist Workers Party which asks the Commission to continue a partial reporting exemption. Ms. Hemsley summarized the conclusions reached in the three drafts.**

**Chair Weintraub recognized Mr. Lindsey Frank, requestors' counsel, who participated in the discussion that followed.**

**Chair Weintraub recognized Vice Chairman McGahn who**

**MOVED to approve Draft C, as set forth in Agenda Document No. 13-07-A, and authorize the Office of the General Counsel to make any technical and conforming edits.**

**The motion carried by a vote of 4-1 with Commissioners Hunter, McGahn, Petersen, and Weintraub voting affirmatively for the decision. Commissioner Walther dissented.**

**Chair Weintraub stated that the Commission issued a press release on Friday, April 19, 2013 summarizing statistics from the 2012 election cycle. The press release includes breakdowns, by the various types of committees, for the approximately \$7 billion that was raised and spent during that election cycle. She provided a brief explanation of how other**

**organizations calculate their totals as compared to the Commission's calculations.**

**IV. DRAFT ADVANCE NOTICE OF PROPOSED RULEMAKING ON TECHNOLOGICAL MODERNIZATION**

**Agenda Document No. 13-14  
(Submitted Late)**

**Chair Weintraub recognized Ms. Selinkoff of the General Counsel's Office who presented the Draft Advance Notice of Proposed Rulemaking. The Commission is seeking public comment on whether and how it should revise its rules regarding a variety of technological modernization issues. The Commission is considering whether to revise its regulations to 1) reflect electronic transactions such as those made by credit, debit, and gift card; internet-based payment processing; online banking; and text messaging; 2) address the receipt, deposit, accounting, recordkeeping, reporting, redesignation, and reattribution of electronic transactions; and 3) eliminate or update references to outmoded technology. The Commission is seeking comments on: 1) what the general industry practices are in the conduct of electronic transactions and recordkeeping; 2) how commercial and consumer electronic transactions are conducted; 3) what the industry standards and safeguards are, generally, and for vendors and third party processors; and 4) what information is available on ways that political**

**committees receive electronic contributions and otherwise engage in electronic transactions and recordkeeping.**

**Discussion followed.**

**Chair Weintraub recognized Commission Walther who**

**MOVED to approve Agenda Document No. 13-14 and authorize the Office of the General Counsel to make any necessary technical and conforming amendments.**

**The motion carried by a vote of 5-0 with Commissioners Hunter, McGahn, Petersen, Walther, and Weintraub voting affirmatively for the decision.**
