Chairman Goodman recognized Mr. Ginsberg and Mr. Tyler Hagenbuch, the requestor's counsel, who were present to answer Commissioners' questions.

Chairman Goodman recognized Mr. Theodore Lutz of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to Crowdpac's request. Crowdpac, a for-profit corporation, proposes to offer to the public a web-based platform through which users can contribute to federal candidates. Mr. Lutz summarized the similarities and distinctions between the two Drafts and asked for the authority to make technical and conforming changes if the Commission approves a Draft.

Mr. Ginsberg and Mr. Adav Noti of the General Counsel's Office participated in the discussion that followed.

Chairman Goodman recognized Commissioner Weintraub who

Chairman Goodman recognized Ms. Esther Gyory of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and Commission regulations to the request from REED Marketing Consultants, Inc. The requestor, a marketing consulting firm that specializes in financial

services and credit card businesses, asks whether its proposed development and marketing of an affinity credit card program for political committees is permissible. Ms. Gyory asked for authority to make any necessary technical and conforming changes if the Commission approves the Draft.

Chairman Goodman welcomed the requestor's other counsel, Ms. Annie Donaldson, to the meeting.

Chairman Goodman recognized Vice Chair Ravel who

MOVED to approve Agenda Document No. 14-41 and authorize the Office of the General Counsel to make any necessary technical and conforming edits.

Chairman Goodman recognized Ms. Farr who was available by telephone to answer Commissioners' questions.

Chairman Goodman recognized Ms. Joanna Waldstreicher of the General Counsel's Office who presented the draft advisory opinion concerning the application of the Federal Election Campaign Act of 1971, as amended, and

Commission regulations to the request. Ms. Farr is an independent candidate for the U.S. Senate from Oklahoma and asks whether her principal campaign committee may use campaign funds to purchase copies of a book she authored for distribution to the committee's contributors at a standard discounted rate. Ms. Waldstreicher asked for authority to make any technical and conforming changes if the Draft is approved.

Chairman Goodman recognized Vice Chair Ravel who

MOVED to approve Agenda Document No. 14-39 and authorize the Office of the General Counsel to make any necessary technical and conforming edits.

The motion carried by a vote of 6-0 with Commissioners Goodman, Hunter, Petersen, Ravel, Walther, and Weintraub voting affirmatively for the decision.

The motion failed by a vote of 3-3 with Commissioners Ravel, Walther, and Weintraub voting affirmatively for the motion. Commissioners Goodman, Hunter, and Petersen dissented.

Chairman Goodman recognized Commissioner Hunter who

Chairman Goodman announced that he and Vice Chair Ravel will host a  
public forum at the Commission on September 17, 2014 to hear ideas and  
discuss how the Commission can update, enhance, and improve the FEC  
website and its contents. This forum, which is part of the Commission's  
ongoing effort to improve public disclosure functions, will include: 1) open  
discussions with Commissioners and senior staff about what the press,  
public, and interest groups who use the data on a day-to-day basis want to  
see on the website; and 2) working group break-out sessions with  
Commission staff, moderated by 18F, a General Services Administration  
organization that is helping the Commission to design and build an intuitive



customer-focused website. Chairman Goodman thanked Vice Chair Ravel for her leadership and Mr. Palmer and the Information Technology staff for their hard work and leadership on this project.

Chairman Goodman recognized Vice Chair Ravel who also encouraged the public to attend the forum. She noted that because public disclosure is central to the Commission's mission, it is critical that the Commission find better ways to deliver campaign finance information to the public by making it more usable, understandable, accessible, and easy to manipulate. Vice Chair Ravel stated that she was pleased to work with the Chairman in this effort to improve the website and the delivery of information, and she also thanked Mr. Palmer and Commission staff who have been working and helping to move this forward with such alacrity.
